

been given in the manner and for the time required by law;

And it appearing that said account is in all respects true and correct and that it is supported by proper vouchers; that the said report and statement are now settled and allowed and the payments are now approved by this Court;

It further appearing that all claims and debts against said decedent, all taxes owing by said estate, including the debts and charges of administration have been fully paid and discharged; that said estate is ready for distribution and in condition to be closed.

And it further appearing that the said Mary B. Guthrie, sometimes known as Mary Guthrie, died intestate on the 21st day of January, A. D., 1937 and left her surviving as her heirs and only heirs at law:

Your petitioner, Fred Guthrie, son, of the age of 40 years, residing at Halfway, Wyoming;

Marie C. Black, daughter, age 42 years, residing at Nyssa, Oregon.

Now, therefore, on the petition of Fred Guthrie, administrator, as aforesaid, and on motion of counsel for said administrator, and no objections being made thereto;

IT IS ACCORDINGLY, ORDERED, ADJUDGED AND DECREED that the said final account of said administrator, and the same is hereby settled, allowed, and approved.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED, and the Court does hereby order that the residue of said estate hereinafter particularly described, now remaining in the hands of said administrator, and any and all other property, whether real or personal and whether known or which may be hereinafter discovered, which may belong to said estate or in which said estate may have any interest and wherever situate, be and the same is hereby assigned, set over and distributed to the said Marie C. Black and your petitioner, the said Fred Guthrie, share and share alike; and for the sole use and benefit of the said distributees;

And the said estate is absolutely vested in the said Marie C. Black and Fred Guthrie, now and forever, to have and to hold the same together with all hereditaments and appurtenances thereunto belonging or in any wise appertaining, to the above named persons, whose heirs and assigns, forever, and in the proportionate part and manner, to-wit:

One-Half ( $\frac{1}{2}$ ) of the whole of the residue of said estate hereinafter described to Marie C. Black, daughter of said deceased, and

One-Half ( $\frac{1}{2}$ ) of the whole of the residue of said estate hereinafter described to Fred Guthrie, son of said deceased.

The following is a particular description of said estate referred to in this decree and of which distribution is now ordered as aforesaid, to-wit:

**AN UNDIVIDED ONE-THIRD ( $\frac{1}{3}$ ) INTEREST IN AND TO**

The Southeast Quarter ( $SE\frac{1}{4}$ ), the East Half of the Southwest Quarter ( $E\frac{1}{2}SW\frac{1}{4}$ ) and Lot Seven (7) of Section Six (6), Township Thirty-three (33) North, Range One Hundred Thirteen (113) West of the Sixth (6th) Principal Meridian, Wyoming.
