

It is further understood and agreed that should said party of the second part allow his buildings and improvements to remain on said above described premises after the thirty (30) day period specified for removing same, party of the first part may attach said buildings and improvements for unpaid rental and cause the same to be sold according to law to satisfy her claim.

It is further understood and agreed that this lease may be extended at the termination hereof, upon such terms and conditions as may be agreed upon by and between parties hereto.
