Tartar, a co-partner in "Tartar and Schwartz", whose name appears as one of the grantees in that certain quit claim deed dated June 21, 1906, and filed for record July 5, 1906, in book 3 of transcribed deeds on page 388 in the office of the County Clerk and Ex-Officio Register of Deeds at Pinedale, Sublette County, Wyoming; and one Tarter, whose name appears as Tarter in "Tarter and Schwartz, a corporation", in that certain warranty deed dated June 21, 1906 and filed for record March 14, 1907 in Book 3 of transcribed deeds on page 588 in the office of the County Clerk and Ex-Officio Register of deeds at Pinedale, Sublette County, Wyoming; and one, Mrs. F. M. Tarter, whose name appears as Mortgagee on that certain mortgage dated Oct. 25, 1910 and filed for record Nov. 1, 1910 in Book 6 of transcribed mortgages on page 508 in the office of the County Clerk and Ex-Officio Register of Deeds at Pinedale, Sublette County, Wyoming; and one, Fannie M. That I was well acquainted with one Rudolph Schwartz, a co-partner in "Tarter and Schwartz" in that certain quit claim deed dated June 21, 1906 and filed for record July 5, 1906 in Book 3 of transcribed deeds on page 388 in the office of the County Clerk and Ex-Officio Register of Deeds at Pinedale, Sublette County, Wyoming; and one, Schwartz, whose name appears as Schwartz in "Tarter and Schwartz, a corporation" in that certain warranty deed dated June 21, 1906 and filed for record March 14, 1907 in book 3 of transcribed deeds on page 588 in the office of the County Clerk and Ex-Officio Register of Deeds at Pinedale, Sublette County, Wyoming; and one, Rudolph Swartz, whose name appears as one of the grantors on that certain warranty deed dated July 15, 1916 filed for record August 4, 1916 in book 5 of transcribed deeds on page 253 in the office of the County Clerk and Ex-Officio Register of Deeds at Pinedale, Sublette County, Wyoming; That the said Rudolph Schwartz, Schwartz, and Rudolph Swartz, all are one and the same person.

That the aforesaid Tarter and Schwartz, also known as Tartar and Schwartz, operated as a co-partnership and never as a corporation.
