THIS AGREEMENT, made and entered into this 7th day of May, 1938, by and between Walter  
W. Scott and Lula Mae Scott, husband and wife, of Pinedale, Sublette County, State of Wyoming,  
hereinafter called the parties of the first part, and Charles Wiederanders, of Pinedale, Sub-  
lette County, State of Wyoming, hereinafter called the party of the second part.

WITNESSETH, that WHEREAS, said parties of the first part have offered to sell to said  
party of the second part, certain real and personal property hereinafter described for the  
sum of FIVE THOUSAND FIVE HUNDRED DOLLARS (\$5,500.00), to be paid for in monthly installments  
of One Hundred Dollars (\$100.00) per month, commencing with the 15th day of June, 1938, to-  
gether with interest at the rate of six per centum per annum on deferred payments, all as  
hereinafter more particularly set forth, and

WHEREAS, said party of the second part does hereby accept the said offer of said parties  
of the first part.

NOW THEREFORE, said parties of the first part, for and in consideration of the payments,  
covenants, promises and agreements hereinafter set forth, to be made, kept and performed  
by said party of the second part, and upon the express condition, which is hereby declared  
a condition precedent, time being the essence of such condition, that said party of the  
second part, his heirs, executors, administrators and assigns, shall, and do well and faith-  
fully perform the covenants, promises and agreements hereinafter mentioned on his part to  
be kept and performed, do hereby for themselves and their heirs, executors, administrators  
and assigns, covenant, promise and AGREE to convey and assure to said party of the second  
part, by a good and sufficient Warranty Deed and Bill of Sale, subject, however, to the  
taxes for the year A. D. 1938, and subsequent taxes of every kind and nature, for the following  
described real and personal property, situate, lying and being in the Town of Pinedale,  
Sublette County, State of Wyoming, and more particularly described as follows, to-wit:

Lots Eleven (11), Twelve (12), Thirteen (13), and Fourteen (14), in Block  
Three (3) of the Original Townsite of Pinedale, Wyoming, as said lots and  
block are laid down and described on the official Plat of said original  
Townsit on file and record in the office of the County Clerk and Ex-Officio  
Register of Deeds within and for said Sublette County, Wyoming;

Together with all improvements now on said property and such other improvements as may
