Now on this 3rd day of June, 1946, this cause coming on regularly for trial to the Court on the petition of plaintiffs herein filed, and plaintiffs being present in court, by their attorneys, Ivan S. Jones, Esq., and Patrick J. Quealy, Esq.; G. B. Hockett, Esq., heretofore appointed by the Court as attorney for defaulting defendants, having answered herein, and said defaulting defendants being also present in court by said G. B. Hockett, Esq., pursuant to such appointment; and the default of each and all of the above named defendants having been heretofore taken and entered herein; and witnesses in behalf of plaintiffs having been sworn, and having testified herein, and defendants having offered no testimony herein; the Court, being now fully advised, finds generally in favor of plaintiffs, and against defendants, and against each and all of them, and that plaintiffs are entitled to judgment and decree against said defendants, and against each and all of them, quieting title in plaintiffs and against defendants and each and all of them, and all persons claiming under, by or through them, or any of them, in and to the real property described in plaintiffs' petition herein, and hereinafter particularly described, and cancelling the written instrument of lease in said petition mentioned, described and hereinafter particularly mentioned and identified: It is, Therefore,

ORDERED, ADJUDGED and DECREED, that the plaintiffs were, at the commencement of this action, and now are, seized in fee and in possession of the real property in plaintiffs' petition and hereinafter described; that the defendants have not, nor has any of them, any estate, right, title, claim or interest in or to the same, or any part thereof; and that the title of plaintiffs thereto be, and the same hereby is, quieted against defendants, and against each and all of them; and that the defendants are, and each of them is, and all persons claiming under, by or through them, or the instrument of writing hereinafter cancelled, are hereby forever enjoined and restrained from bringing any action against plaintiffs in regard to plaintiffs' title or possession of said real property, and from claiming or asserting any estate, right, title or interest in or to said real property adverse to plaintiffs' right. It is Further,

ORDERED, ADJUDGED and DECREED, that a certain indenture of lease mentioned in plaintiffs' petition, in this cause, said indenture of lease being dated the 30th day of August, 1937, between Frank A. Fear and Jessie A. Fear, his wife, as first parties, and C. Ed Lewis, as second party, describing therein the same real estate herein quieted in plaintiffs, said indenture of lease being recorded in Book 1, of Oil and Gas Leases, on page 131, under instrument number 19619, of the records of the County Clerk and Ex-Officio Register of Deeds in and for Sublette County, Wyoming, and all rights of defendants thereunder have expired and terminated, and that the said indenture of lease be, and the same hereby is cancelled, dissolved and set aside; and that the same be cancelled and delivered up to plaintiffs, and upon failure of defendants to so cancel and deliver the said indenture, the same be, and hereby is cancelled of record in said County.
