This agreement, made and entered into this 6th day of June A. D. 1946 by and between  
 R. L. Banes and Nellie V. Banes owner of the real estate herein described, party of the  
 first part, and Dan Samora party of the second part.

Witnesseth. That for and in consideration of the covenants and agreements hereinafter  
 set forth, to be kept and performed by the parties hereto, the said party of the first part  
 does hereby lease and demise unto the party of the second part, the following described  
 premises and real estate situate in the County of Sublette and State of Wyoming, viz:

The Lot (1) and Southeast Quarter of Northeast Quarter (SE $\frac{1}{4}$ NE $\frac{1}{4}$ ),  
 Section Four (4); Township 32, North, Range 108 West of the Sixth  
 Principal Meridian, Wyoming, premises together with all improvements. /one

Together with irrigation water rights belonging thereto.

RENTAL. As rental for the use and occupancy of said premises, the party of the second  
 part agrees to pay to the party of the first part the following:

Five Hundred Forty Dollars (\$540.00) to be paid as follows, to-wit:  
 the sum of One Hundred eighty Dollars (\$180.00) at the signing and  
 sealing of this instrument; the sum of One Hundred eighty Dollars  
 (\$180.00) on or before June 6, 1947, and likewise the sum of One  
 Hundred eighty dollars (\$180.00) on or before June 6, 1948.

TERMS OF LEASE, The terms of this lease shall begin on the 6th day of June 1946 and  
 continue during and until the 6th day of June 1949, unless sooner terminated by violation  
 of any of its conditions, or by mutual agreement. Whenever terminated, the party of the
