

It is therefore ordered, adjudged and decreed that the said final account of said Executrix be and the same is hereby settled, allowed and approved.

It is further ordered, adjudged and decreed, and this Court does hereby order that the residue of said estate of Andrew Homer, deceased, hereinafter particularly described now remaining in the hands of said Executrix, and any other property now or hereinafter discovered which may belong to the said estate, or in which the said estate may have any interest, be and the same is distributed to, and divested, absolute, in Elizabeth E. Homer, Glyndon Elizabeth Homer, Arthur Charles Homer, and Paul Logan Homer, forever, to have and to hold the same to the above named persons, their heirs and assigns, forever, and in the proportionate part and manner, to-wit:

To Glyndon Elizabeth Homer, the sum of one (\$1.00) Dollar lawful money of the United States.

To Arthur Charles Homer, the sum of one (\$1.00) Dollar lawful money of the United States.

To Elizabeth E. Homer, all the rest and residue of said estate as hereinafter described of every kind, nature and description, and wherever situated and whether now or hereinafter discovered.
