DECREE OF DIVORCE.

The above entitled cause coming on regularly to be heard upon the petition of the Plaintiff, and it appearing to the Court that due service of summons has been had upon the defendant in the State of Wyoming, and that time for answer has expired, and that he is in default of answer or other pleading, and that he has filed no pleading in answer to said petition, he is hereby found to be and adjudged to be in default; and the matter coming on for trial, and the Court having heard the evidence of the plaintiff, who appeared in person and by her attorney, Thomas M. McKinney; and being fully advised in the premises, finds generally in favor of the plaintiff and against the defendant, and that she should be awarded a decree of divorce from the defendant;

IT IS, THEREFORE, FURTHER ORDERED, ADJUDGED AND DECREED that the plaintiff Hilda Hazel Gorey be and she hereby is awarded a decree of absolute divorce from the defendant Frank Gorey, and the bonds of matrimony between them are vacated, set aside and held for naught.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that Lot 14, Block 18 in the Town of Pinedale, Sublette County, Wyoming, being the property of the Plaintiff and defendant, be and the same is hereby set over and conveyed to the plaintiff Hilda Hazel Gorey, as her absolute property.
