ORDER SETTLING FINAL ACCOUNT AND DECREE OF DISTRIBUTION.

Minnie M. Budd, Administratrix of the estate of Mary E. Dempsey, deceased, having on or before the 21st day of October, 1930, rendered and filed herein a full account and report of her administration of said estate, which account was for final settlement, and having with said account filed a petition for the final distribution of the estate;

And said account and petition this day coming on regularly to be heard, and proof having been made to the satisfaction of the Court that the Administratrix has given notice of the settlement of said estate and the filing of said petition in the manner and for the time required by law;

And it appearing that said account is in all respects true and correct; that the residue of the property in the hands of the Administratrix, at the time of filing said account, is hereinafter particularly described as follows:

REAL ESTATE:

The West half of the Southwest quarter (W $\frac{1}{2}$ SW $\frac{1}{4}$), the Northeast quarter of the Southwest quarter (NE $\frac{1}{4}$ SW $\frac{1}{4}$), and the Northwest quarter of the Southeast quarter (NW $\frac{1}{4}$ SE $\frac{1}{4}$) of Section two (2), in Township Thirty-six (36) North of Range One Hundred Fourteen (114) West of the Sixth Principal Meridian, Wyoming, containing 160 acres more or less.

PERSONAL PROPERTY:

None.

That since the rendition of said account no other monies or any other property whatsoever has come into the hands of this Administratrix on account of said estate.

And it appearing that all claims and debts against said decedent, all taxes on said estate, and all debts, expenses and charges of Administration have been fully paid and discharged, and that a proper certificate from the Inheritance Tax Commissioner of the State of Wyoming, showing all Inheritance Tax due to be paid, has been filed with the Clerk of this Court in the matter of said estate, and it appearing to this Court that said estate is ready for distribution and in condition to be closed;

The Court further finds that the said Mary E. Dempsey died intestate on or about the 23rd day of June, 1923, and left as her heirs at law, who are entitled to distribution of her estate, the following named persons, to-wit:

Minnie M. Budd, Age 44 years, daughter, Big Piney, Wyoming.

IT IS THEREFORE ORDERED that said payment of the expenses of administration are approved, and said statement of expenditures and disbursements is now settled and allowed, and

IT IS FURTHER ORDERED, ADJUDGED and DECREED that the final account of said Minnie M. Budd be, and the same is hereby settled, allowed and approved, and that the residue of said estate hereintofoe particularly described, and any other property which may belong to said estate, or in which the said estate may have any interest, be, and the same is hereby distributed as follows: all of the property hereinabove described and now in process of probate herein, and belonging to the estate of Mary E. Dempsey, deceased, is hereby distributed to:

Minnie M. Budd, Age 44 Years, daughter, Big Piney, Wyoming.
