THIS INDENTURE, made and entered into this 26th day of March, 1947, WITNESSETH:

That Effie May Rahm and Harry H. Rahm, to be hereinafter known as Lessors, do hereby lease, demise and let unto the Bar-Cross Land and Livestock Company, Inc., to be hereinafter known as the Lessee, the following described lands and premises, to-wit:

Section Sixteen (16), Township Thirty-six (36) North, Range One hundred ten (110) West of the Sixth (6th) Principal Meridian, Wyoming, together with all improvements located thereon.

To have and to hold, for the term of Three (3) years, to-wit: from the first day of May, 1947, until the first day of May, 1950, yielding and paying therefore the rent of Seventy-five and no/100 (\$75.00) Dollars per annum; and the said Lessee promises to pay said rent as follows, to-wit:

Seventy-five and no/100 (\$75.00) Dollars on or before May 1, 1947, and likewise the sum of Seventy-five and no/100 (\$75.00) Dollars on or before May 1, 1948, and Seventy-five and no/100 (\$75.00) Dollars on or before May 1, 1949, and to quit and deliver up the premises together with improvements to Lessors peacefully and quietly at the end of said term, in as good order and condition as the same now are or may be put into (reasonable use and wear thereof and damages by the elements accepted), and not make or suffer any waste thereof, nor lease, nor underlet, nor permit any other person or persons to occupy the same, and the Lessors may enter to view and make improvements and to expell the Lessee if it shall fail to pay the rent as aforesaid.

And should default be made in any of the payments in any portion of the rent when due, then in that event, the Lessors may give to said Lessee Thirty (30) days notice of said default and if said Lessee shall not remedy said default within said Thirty (30) days, the said Lessors may re-enter, and at their option terminate this lease.
