ORDER AUTHORIZING CONVEYANCE OF PROPERTY

Mary A. Murdock, Mother of Solon Gibson Murdock, deceased, having filed her petition herein alleging that she was and is now the owner of the property hereinafter described she having acquired the same under and pursuant to a Patent from The United States of America under date of May 3, 1911,

And it appearing that on or about September 10, 1936 the said Mary A. Murdock conveyed to Solon Gibson Murdock and undivided one-eighth (1/8) interest in and to the lands, property and premises hereinafter described, but that said Conveyance was made in error and was inadvertent and the grantor never intended to convey to the said Solon Gibson Murdock said lands, property and premises hereinafter described,

And it further appearing that the estate of Solon Gibson Murdock claims no interest in said property and never listed the same for probate or included it as part of the assets of said estate and that the Administratrix of said estate admits the facts stated in the Petition of Mary A. Murdock and joined therein.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that Carrie J. Murdock, Administratrix of the Estate of Solon Gibson Murdock, be and she is hereby authorized, empowered and directed to convey to Mary A. Murdock by Administratrix Deed all the right, title and interest of Solon Gibson Murdock, deceased, and all the right, title and interest which the Estate of Solon Gibson Murdock may have acquired by operation of law or otherwise, the following described lands, property and premises situate in Sublette County, Wyoming, to-wit:

Lot One (1), South half of Northeast Quarter (S $\frac{1}{2}$ NE $\frac{1}{4}$ ), North Half of Southeast Quarter (N $\frac{1}{2}$ SE $\frac{1}{4}$ ) Section Twenty (20) and Lot Four (4) and Nine (9), Southwest Quarter Northwest Quarter (SW $\frac{1}{4}$ NW $\frac{1}{4}$ ) Section Twenty-one (21) all in Township Thirty (30) North, Range One Hundred Ten (110) West of the Sixth (6th) Principal Meridian, Wyoming. Together with all improvements and together with all water and water rights, ditch and ditch rights and the rights to the use of water and ditches belonging to and used in connection with said above described property.
