ORDER APPROVING REPORT OF RECEIVER AND DIRECTING EXECUTION OF CONVEYANCE

The report by Receiver and petition for distribution and conveyance heretofore filed herein by Gail Ziegler, Receiver of New Fork Ranch Company, a defunct corporation, coming on regularly to be heard this 16th day of October, 1947, and from evidence adduced the Court finds as follows:

That said New Fork Ranch Company was duly organized and incorporated under and by virtue of the laws of the State of Wyoming, having filed its articles of incorporation on May 28, 1901, but that its corporate franchise was revoked on December 5, 1923, on account of its failure to file the annual reports required by law;

That the Board of Directors of said New Fork Ranch Company at the time that its corporate franchise was revoked were, so far as is known, Edward A. Buck, William W. Bower and Theo. Tragoning; and that said Edward A. Buck, William W. Bower and Theo. Tragoning are all now dead;

That upon due and proper proceedings herein, said Gail Ziegler was appointed Receiver of said New Fork Ranch Company, a defunct corporation, by and order made and entered by this Court on the 24th day of April, 1947; that on the 20th day of May, 1947, she posted bond as required by said order and duly qualified as such Receiver; and that she is now the duly appointed, qualified and acting Receiver of said New Fork Ranch Company, a defunct corporation;

That on May 22nd and 29th and June 5th, 1947, said Receiver duly published notice in Pinedale Roundup, Pinedale, Wyoming, addressed to creditors, stockholders and others persons interested in said New Fork Ranch Company, advising of her appointment as such Receiver and requiring all creditors, stockholders and other persons interested in said corporation, or having claims against it, to exhibit such claims for allowance to said Receiver at Pinedale, Wyoming, within four months from the first publication of said notice; that more than four months have elapsed since the first publication of said notice; and that no claims or demands of any kind have been filed;
