DECREE

THIS MATTER, coming on regularly to be heard this 6th day of February, 1948, upon the petition filed herein by D. D. Edwards, and it appearing to the Court that notice of the hearing on said petition was published and given in accordance with the Order Fixing Time and Place of Hearing, heretofore made and entered herein, and that no one has appeared to object to, or contest said petition, and that no objections have been filed thereto;

And the Court, after examining the files and records in this proceeding, and hearing the evidence offered in support of said petition, and being fully advised in the premises, finds that Idonna Edwards a resident of Sublette County, Wyoming, died intestate in Sweetwater County, Wyoming, on the 23rd, day of November, 1947, that said D. D. Edwards and Idonna Edwards were married on July 5th, 1946, at Livingston, Montana, and were husband and wife continuously from said date until the death of said Idonna Edwards.

That there are no children as the issue of said marriage and that under the intestate laws of the State of Wyoming, D. D. Edwards is the sole heir at law of Idonna Edwards, deceased.

That on the 11th, day of September, 1947, said D. D. Edwards and Idonna Edwards, husband and wife, purchased the following described real property from Hyrum Arthur Nelson and Katherine M. Nelson, husband and wife, to-wit:

Lots 8, 9, 10 in Block 23 in the Hennick Addition to the Town of Pinedale, Sublette County, Wyoming together with the improvements thereon.

That Hyrum Arthur Nelson and Katherine M. Nelson, husband and wife, duly and regularly executed and delivered a Warranty Deed, dated September 11th, 1947, in favor of said D. D. Edwards and Idonna Edwards, husband and wife, as grantees, which deed was duly and regularly recorded in the office of the County Clerk and Ex-Officio Register of Deeds within and for Sublette County, Wyoming, on the 11th, day of September, 1947, in Book 5 of Deeds, on Page 145; that at the time of said purchase and the execution and delivery of said deed, said D. D. Edwards and Idonna Edwards were husband and wife, and said conveyance was made to them as such husband and wife, and created an estate by the entireties in favor of said D. D. Edwards and Idonna Edwards, husband and wife, and they owned and held title to said real estate as tenants by the entireties continuously from said 11th day of September, 1947, until the death of said Idonna Edwards; that said D. D. Edwards was and is the surviving husband of said Idonna Edwards, deceased, and by virtue
