KNOW ALL MEN BY THESE PRESENT: That Charles A. Meeker of the U.S. Naval Destroyer Base, San Diego, California, for and in consideration of valuable consideration, in hand paid by, Walton Dismukes, Lt. Comdr (SC) US Navy, of the Naval Air Station, San Diego, California, hereinafter called the assignee, the receipt of which consideration is acknowledged and confessed, do hereby sell, assign, transfer, convey and setover unto the said assignee Mr. Walton Dismukes, all my right, title and interest in and to one (1) acre of 1/8 royalty or twelve and one half percent of all oil and gas produced and saved from the property described below, and under the terms and definitions as set forth:

NE $\frac{1}{4}$  of the NE $\frac{1}{4}$  of Section 10; Township 29 North, Range 113 West of the 6th P.M., Sublet County, Wyoming.

This deed is to include the right to one fortieth (1/40) of all the land owners rights to all the one eighth (1/8) royalty on all oil and gas produced and saved from this particular forty acres of ground, known generally as the Budd Well # 1 forty, regardless of the number of wells drilled or the location of same on this particular forty acres. It does not include the right to any other forty acres in the Budd Ranch.

It is understood that so far as is known that the title to the above mentioned royalty is clear, and that there are no liens which can be assessed to the interest assigned Mr Walton Dismukes, except that should oil or gas be produced within two years from May 1, 1939 that \$160.00 one hundred sixty dollars is assessed against the interest of Mr Walton Dismukes, the sum to be paid to Mr Charles A. Meeker or his assigns. It is understood that the sum is to be paid from the oil and gas produced from the first well, and only the first well, and then only if the well produces at the rate of twenty five dollars (\$25.00) per day or over.

To have and to hold unto the said assignee, his heirs, administrator, and assigns said one acre of royalty as above set forth, the oil and the gas as produced and saved from said lands, to be delivered free of cost to the royalty owner in accordance with the terms of the lease held by the Wyoming Petroleum Company.
