Decree of Distribution.

The petition of Mat Strous, also known as Matt Strous, and Frank Strous, the duly appointed, qualified and acting Executors of the Estate of Ed Strous, deceased, heretofore filed herein, praying for the distribution of the residue of the estate of said Ed Strous, deceased, in the hands of the Executors of said estate, among the persons entitled thereto, coming on regularly for hearing, and it duly appearing to the Court that due and legal notice of such hearing has been given and published for the time and in the manner and form as required by law, as shown by the proof thereof filed herein; that all claims against said estate are fully paid; that the final account and report of said Executors has been duly made and has been approved and confirmed by this Court; that all taxes due from said estate, both state, County, School, and inheritance tax have been fully paid and settled; that the costs and expenses of administering said estate, and the expenses of the last illness of said deceased, as well as the funeral expenses, have been fully paid and discharged; that more than six months have expired since the 31st day of July, 1947, the date of the first publication of Notice to Creditors of said estate was given and published; that no objections, either oral or in writing, were either made or filed in this said matter within the time as required by law and said notice thereof, by any person interested in said estate, or otherwise, or at all, and said estate now stands in a condition to be closed.

That said deceased, Ed Strous, died testate, and under the provisions of the last will and testament of said deceased, admitted to probate herein, the residue of said estate, was given, devised and bequeathed to his two sons, Mat Strous, also known as Matt Strous and Frank Strous, Executors herein, and as such devisees and legatees are entitled to have decreed and distributed to them, the residue of said estate, both real and personal, belonging to said estate.

That all of the personal property of said estate has been converted into cash, and all of the moneys have been paid out, as shown by the final account and report filed and heretofore approved and confirmed herein, and the residue of said estate, consists of the real estate, described as follows, to-wit:

The Northwest quarter of Section twenty-four in Township Thirty-three, North, Range One hundred nine West of the 6th Principal Meridian, in Sublette County, Wyoming, containing 160 acres of land.

And all and singular the Court being fully advised in the premises, it is therefore, considered, ordered, adjudged and decreed that the above described real estate be and the same hereby is decreed and distributed to said Mat Strous also known as Matt Strous, the devisees thereof under said will, as their sole and absolute property in equal portions, share and share alike. This said estate being less than \$2,000.00 in value, no fees are required to be paid herein as required by Section 6-2804, Wyoming Compiled Statutes, of 1945. It is further ordered that this said estate be and the same hereby is closed, said Executors discharged, and their bondsmen relieved from future liability.
