

1 4. That Minnie A. Spaulding died intestate at Big Sandy,
2 Fremont County, Wyoming, on or about the 30th day of November,
3 1913; that at the time of her death said Minnie A. Spaulding was
4 a resident of Big Sandy, Fremont County, Wyoming, and owned and
5 left estate in Fremont County, Wyoming, said estate being herein-
6 after particularly described; and that said Big Sandy, Wyoming,
7 and the estate mentioned are now located in Sublette County, Wyo-
8 ming;

9 5. That Patent No. 714470 was issued by The United States
10 of America to the Heirs of Minnie A. Spaulding on the 22nd day of
11 October, 1919; that said Patent was filed for record on the 10th
12 day of January, 1930 in the office of the County Clerk and Ex-Off-
13 icio Register of Deeds of Sublette County, Wyoming; and that said
14 Patent granted, to the Heirs of Minnie A. Spaulding, pursuant to
15 the Act of Congress of May 20, 1862 and the acts supplemental there-
16 to, the following described real property, and said estate con-
17 sists of:

18 The Southeast Quarter of the Northwest
19 Quarter (SE $\frac{1}{4}$ NW $\frac{1}{4}$), and the South Half of
20 the Northeast Quarter (S $\frac{1}{2}$ NW $\frac{1}{4}$) of Section
21 Twenty (20); and the Southwest Quarter
22 of the Northwest Quarter (SW $\frac{1}{4}$ NW $\frac{1}{4}$) of Sec-
23 tion Twenty-one (21); all in Township
24 Thirty (30) North, Range One Hundred
25 Five (105) West of the Sixth (6th) Prin-
26 cipal Meridian, Wyoming, together with
27 all water rights, ditches, rights of
28 way and improvements situated thereon
29 or appertaining thereto.

30 6. That more than two years have elapsed since the death
31 of said Minnie A. Spaulding; and that there has been no previous
32 record judicial determination of said decedent's heirs or the right
33 of descent of said real property interest;

34 7. That said Minnie A. Spaulding, deceased, left her sur-
35 viving, as her only heir at law, the following named person:

36 Altheair Parkinson Over 21 Daughter
37 527 North Main, Pocatello, Idaho,

38 and that petitioner derived title to the real property hereinabove
39 described by and through conveyances from the heir of said Minnie
40 A. Spaulding, deceased, to-wit: the said Altheair Parkinson, and
41 that C. Parkinson, petitioner, is now the owner of said real proper-
42 ty.

43 IT IS, THEREFORE, ORDERED, ADJUDGED AND DECREED that said
44 Minnie A. Spaulding died intestate at Big Sandy, Fremont County,
45 Wyoming, on or about the 30th day of November, 1913, and that upon
46 the death of said Minnie A. Spaulding, as aforesaid, all of her
47 right, title and interest in and to the following described real
48 property, and in and to all estate owned by her at the date of her
49 death, vested in Altheair Parkinson, daughter of decedent, her heirs
50 and assigns forever:

51 The Southeast Quarter of the Northwest
52 Quarter (SE $\frac{1}{4}$ NW $\frac{1}{4}$), and the South Half of
53 the Northeast Quarter (S $\frac{1}{2}$ NW $\frac{1}{4}$) of Section
54 Twenty (20); and the Southwest Quarter
55 of the Northwest Quarter (SW $\frac{1}{4}$ NW $\frac{1}{4}$) of Sec-
56 tion Twenty-one (21); all in Township Thir-
57 ty (30) North, Range One Hundred Five (105)
58 West of the Sixth (6th) Principal
