

RELEASE OF REAL ESTATE WATER CONTRACT

KNOW ALL MEN BY THESE PRESENTS, That the Fremont Irrigation Company, a corporation, of the County of Sublette, and State of Wyoming, does hereby certify that a certain Agreement, bearing date the 23rd day of May, 1943, made and executed by Fremont Irrigation Company, a corporation, as grantor, to Jack E. Davis, as grantee, conveying certain water rights and water in consideration for the payment of \$750.00, as therein stated, which agreement was recorded in the office of the County Clerk and Ex-Officio Register of Deeds of Sublette County, State of Wyoming, on the 24th day of June, 1948, in Book 10 of Miscellaneous, at page 348, and thereby effecting a lien against the following described real estate in said County, to-wit:
