DECREE OF DISTRIBUTION

The Petition of Velma C. Budd and Nelse P. Christensen heretofore filed herein, praying for the distribution of the residue of the estate of Henry L. Budd, deceased, to the persons entitled thereto, coming on regularly to be heard this 21st day of June, 1949, and it appearing that due Notice of such hearing has been given as required by law; that all claims against said estate are fully paid; that the Final Account of said Administrators has been duly made and approved by this Court, and that all taxes due from said estate (including Inheritance Tax) have been paid;

That said deceased died intestate, and his only heirs are his widow, Velma C. Budd, who is entitled to one-half of said estate, and his two children, William H. Budd and Pearl C. Spencer who as such heirs are each entitled to one-fourth of said residue, each over the age of 21 years and residents of the County of Sublette, State of Wyoming.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED, that the residue of said estate be distributed as follows, to-wit:

One-half to Velma C. Budd,  
One-fourth to William H. Budd and  
One-fourth to Pearl C. Spencer;

That the property constituting said residue and affected by this Decree is described as follows, to-wit:

Quarter Southwest Quarter ( $NW\frac{1}{4}SW\frac{1}{4}$ ), Section  
Thirty-two (32), Township Thirty-one (31) North.
