16 NOW, on this 9th day of December, 1948, this cause coming
17 on for trial to the Court, on the Petition filed herein by Plaintiffs
18 and it appearing to the Court that each and all of the Defendants

Summons, in the manner and for the time provided and required by law

20 IT IS THEREFORE ORDERED, that each and all of said Defendants
21 be, and they hereby are, adjudged in default herein.

22 Witnesses in behalf of Plaintiffs having been sworn and
23 having testified herein, the Court DOTH SAY AND FIND:

24 That all and singular the allegations in Plaintiffs' Peti-
25 tion contained are true; that Plaintiffs are lawfully seized in fee
