DECREE

Rosalie E. Hockett, the administratrix of the Estate of Guy B. Hockett, also known as G. B. Hockett, deceased, and being the surviving widow of said deceased, having filed herein her petition praying that all of the property of said estate be decreed to be the exempt homestead property of said surviving widow of said deceased, and set over to her as her sole property; and it appearing to the Court that:

Said Guy B. Hockett, also known as G. B. Hockett, died on the 6th day of August, 1951, being at the time of his death a resident of said Sublette County, in the State of Wyoming, leaving him surviving his widow, the said Rosalie E. Hockett; that said Rosalie E. Hockett, the petitioner aforesaid, was appointed administratrix of said deceased on September 10, 1951, and, on September 10, 1951, letters of administration were issued to said Rosalie E. Hockett, and have not been revoked; that on the 20th day of September, 1951, said administratrix made first publication of Notice to Creditors of said deceased, and combined with the same notice, a notice of the filing of her said petition for exemption to her of all of the property of said estate, and of the time and place when and where said petition would be heard by the Court; that on the 12th day of September, 1951, said administratrix returned into this court Inventory and Appraisement of said estate, in which said Inventory and Appraisement the value of all of the property of said estate was and is fixed and appraised at the sum of \$1,589.26, and no more, and, by the appraisers thereof, set off and admeasured as the exempt homestead property of said surviving widow of said deceased;

The expenses of last illness and funeral expenses of said deceased, and all expenses of administration have been paid and satisfied, and publication of the order of this court setting said petition for hearing has been made by said administratrix, as required by law: It Is, Therefore,

ORDERED, ADJUDGED and DECREE, that all of the property of said estate be, and the same hereby is, set over and distributed to said Rosalie E. Hockett, surviving widow as aforesaid, to her, her heirs and assigns, forever, in fee, free and clear of all debts and charges against the estate of said deceased; and that no further administration be had herein unless further estate shall be discovered. The following is a description of the estate hereby distributed and set over, to-wit:

Lots 19 and 20, of Block 9, Big Piney Townsite; the Northwest quarter of Section 15, Township 31 North, Range 111 West 6th Principal Meridian, Wyoming, situate in Sublette County, Wyoming.

E. Lovatt, \$90.00, W. F. Webb, \$115.00, Edward G. Jones, \$470.00; Deposit, Big Piney State Bank, \$43.04.


