McCOLL of Bartlesville, Washington County, State of Oklahoma, its true and lawful Attorney in Fact for it and in its name, place and stead, to enter into and execute on behalf of this corporation agreements pooling royalty on any or all minerals of this corporation under oil and gas leases with royalty on any and all minerals under oil and gas leases of third parties; agreements pooling oil and gas leases and the rights thereunder of this corporation with oil and gas leases and rights thereunder of third parties; agreements providing for the joint or unit development of oil and gas leases of this corporation with oil and gas leases of third parties; agreements pooling unleased interests in minerals of this corporation with unleased mineral rights and with rights in oil and gas leases of third parties; agreements making contributions to third parties in connection with the drilling of wells; agreements sub-ordinating oil and gas leases and the rights thereunder of this corporation to the rights of third parties; agreements for the purchase, or exchange, of oil and gas leases or interests in oil and gas leases and assignments pursuant thereto; agreements for the sale or assignment of oil and gas leases for the purpose of encouraging the development of said area for oil and gas and assignments pursuant thereto; agreements for the renting, leasing, purchase and sale of personal property and easements together with the assignment thereof; division orders covering sale of oil and gas, transfer orders covering sale of oil and gas in connection with the transfer of oil and gas leases and the reduction of overriding royalty; easements on lands owned by this corporation; oil and gas leases on fee lands and on mineral rights in lands of this corporation wherever situated; oil and gas leases on lands of members of any Tribe of Indians, on mineral interests of any Indian Tribe, on public lands and other lands of the United States wherever situated, on public lands and other lands of any State and of any subdivision of any State wherever situated, in which this corporation is lessee; oil and gas leases on any land or mineral interest regardless of ownership wherever situated, in which this corporation is lessee; leases of the surface of lands wherever situated of this corporation for agricultural, grazing and other purposes; subleases of rights under surface leases and under oil and gas leases of this corporation; releases and surrenders of oil and gas leases and of easements in real estate wherever situated, giving and granting unto its said Attorney in Fact full and complete power and authority to do and perform any and all acts and things whatsoever necessary and requisite to be done, as may be necessary and proper in the premises.

Said CITIES SERVICE OIL COMPANY hereby declares that each and every act, matter, and thing which shall be given, made and done by said J. W. McCOLL in connection with the exercise of any or all of the aforesaid powers shall be as good, valid and effectual to all intents and purposes as if the same had been given, made, and done by said CITIES SERVICE OIL COMPANY in its corporate presence and it hereby ratifies whatsoever said Attorney shall lawfully do or cause to be done by virtue hereof.
