AND FINAL DISTRIBUTION.

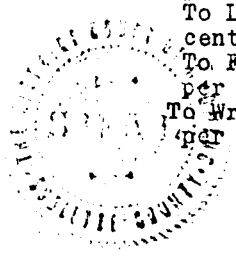
