Abstract

Chapter 36, Subchapter D—Lien for Taxes

SEC. 3470. PROPERTY SUBJECT TO LIEN.
If any person liable to pay any tax neglects or refuses to pay the same after demand, the amount (including any interest, penalty, additional amount, or addition to such tax, together with any costs that may accrue in addition thereto) shall be a lien in favor of the United States upon all property and rights to property, whether real or personal, belonging to such person.

SEC. 367L. PERIOD OF LIEN.

Unless another date is specifically fixed by law, the lien shall arise at the time the assessment list was received by the collector and shall continue until the liability for such amount is satisfied or becomes unenforceable by reason of lapse of time.

SEC. 3472 (a). INVALIDITY OF LIEN WITHOUT NOTICE.
Such lien shall not be valid as against any mort-
gagee, pledgee, purchaser, or judgment creditor until
notice thereof has been filed by the collector—

(1) **UNDER STATE OR TERRITORIAL LAWS.**—In the office in which the filing of such notice is authorized by the law of the State or Territory in which the property subject to the lien is situated, whenever the State or Territory has by law authorized the filing of such notice in an office within the State or Territory; or

(2) **WITH CLERK OF DISTRICT COURT.**—In the office of the clerk of the United States district court for the judicial district in which the property subject to the lien is situated, whenever the State or Territory has by law authorized the filing of such notice in an office within the State or Territory; or

(3) WITH CLERK OF DISTRICT COURT OF THE UNITED STATES FOR THE DISTRICT OF COLUMBIA.—In the office of the clerk of the District Court of the United States for the District of Columbia, if the property subject to the lien is situated in the District of Columbia.

For provisions relating to securities, see subsection (b) (1), (2), and (3) of this section.

EC 3472. RELEASE OF LIEN. Subject to such regulations as the Commissioner, with the approval of the Secretary, may prescribe, any collector charged with an assessment in respect of any tax, may issue a certificate of release of the

(a) **LIABILITY SATISFIED OR UNENFORCEABLE.**—The collector finds that the liability for the amount assessed, together with all interest in respect thereof, has been satisfied or has become unenforceable by reason of lapse of time: or

(b) BOND ACCEPTED.—There is furnished to the contractor and accepted by him a bond that is conditioned upon the payment of the amount assessed, together with all interest in respect thereof, within the time prescribed by law (including any extension of such time), and that is in accordance with such requirements relating to terms, conditions, and form of bond and sureties thereon, as may be specified in regulations.
