DECEASED } ROBERTSON COUNTY, TEXAS

On this the First day of October A D 1934, came on to be heard by the court the first amended application of Mrs. Bessie D Burnitt for the probate of a certain instrument in writing now produced in Court, purporting and alleged to be the last will of Pyke Burnitt, deceased; and it appearing that citation has been duly issued and properly served in the manner and for the time prescribed by law, to which no objection has been raised, and that this court has jurisdiction of the matters and things involved herein, and it further appearing from the evidence, a written statement whereof is on file and is hereby ordered to be placed of record in the Minutes of this Court, that said instrument is the last will of him the said Pyke Burnitt, and that same was executed under all the formalities required by law, and it further appearing to the court that the said Pyke Burnitt is dead and that he died in Robertson County, Texas where he had his residence at the time of his death, and for many years prior thereto; and the court being further satisfied that the said Pyke Burnitt died without having ever revoked said will, and it further appearing to the court that no necessity exists for an administration upon the estate of the said Pyke Burnitt, there being no debts owing to or by said estate.

It is therefore the order, judgment and decree of the court that said instrument, dated March 1 A D 1918 and filed in this court on the 22nd day of September A D 1932 be and the same is hereby, admitted to probate and record said instrument, together with the affidavit of Mrs. Bessie D Burnitt applicant and the testimony adduced upon this hearing from S B Swinson, a subscribing witness shall be recorded in the Minutes of this court.

It is the further order, judgment and decree of the court that said Will be admitted to probate and record as a muniment of title, that no letters be granted and no administration opened upon the estate of Pyke Burnitt, deceased, there being no necessity therefor.

It is the further order, judgment and decree of the court that L S Casimir, Scott Field and C W Sparks they being disinterested citizens of Robertson County, Texas shall appraise said estate both as to real and personal property and they, or any two of them are hereby appointed appraisers.

It is the further order, judgment and decree of the court that upon the return and approval of an inventory and appraisement herein and the payment of the costs of court for which let execution issue in favor of the officers, this proceeding shall be and the same is hereby, closed and dropped from the docket of this court.
