## RIGHT OF WAY EASEMENT

Know All Men By These Presents:

That for and in consideration of the sum of One Dollar dollars, the receipt of which is hereby acknowledged and confessed, Ben E. Fowler and Rita J. Fowler, husband and wife,

of the County of Sublette and the State of Wyoming hereinafter called the grantor, hereby grants to the ~~State of Wyoming~~ hereinafter called the grantee, the right to lay out, construct, inspect, operate and maintain a road for the use of the public over and across the following described land located in the County of Sublette and State of Wyoming, to-wit:

The location, width of right of way hereby granted is as follows:

a parcel of land 100 feet in width and described as follows: Commencing west at a point which point is 100 feet of the northeast corner of the NE $\frac{1}{4}$ NW $\frac{1}{4}$  Section 19, Township 33 North, Range 108 West of the 6th Principal Meridian, Wyoming, and running thence West for a distance of 100 feet to a point, dividing and thence running South to a point on the ~~quartermile~~ line between the NE $\frac{1}{4}$ NW $\frac{1}{4}$  and the SE $\frac{1}{4}$ NW $\frac{1}{4}$ , Sec. 19, T.33 N.R.108 West 6th P. M.; and thence running East for a distance of 100 feet to a point; and thence running North to the point of beginning.

Grantor also grants the right of ingress and egress to and from the said land for any and all purposes necessary and incident to the exercise by the grantee, and the public, of the rights granted by this conveyance.

Grantee agrees to fence the right of way on both sides with wire fence with posts feet apart, with gates at such points as are necessary. Grantor to maintain fence thereafter.

Grantee agrees to construct culverts of suitable size across such ditches and laterals of grantor as necessary for proper operation of his irrigation system.

Grantors hereto do hereby waive and release all rights under and by virtue of the homestead exemption laws of the State of Wyoming insofar as affected by this conveyance.

The grant herein contained is an easement and shall be perpetual so long as said land is used for the aforementioned purposes.
