MUNE PRO TUNE ORDER

The matter of the application of the plaintiffs for making and entry of a Mune Pro Tune Order Amending and Correcting the Judgment and Decree heretofore made and entered herein came on regularly for hearing upon motion of R. Dwight Wallace, one of their attorneys of record, and based thereon and the files in the cause, the Court finds;

That the Judgment and Decree of 27 March, 1950 as made, entered and filed did and does not correctly record the judgment as rendered and announced by the Court in that through inadvertence and clerical errors in the drawing of said Judgment and Decree by plaintiff's attorneys the lands covered by the Oil, Gas and Mineral Lease did not correctly or completely describe the lands covered thereby although said lease was held to be of no further force and effect, having been abandoned and was adjudged to be cancelled and released of record; and,

The Court being fully advised in the premises:

IT IS, THEREFORE, HEREBY ORDERED that the Judgment and Decree heretofore made entered and filed herein on the 27th day of March, A. D. 1950, be corrected and amended to conform to the actual judgment made by the Court in that the lands covered thereby being and situate in Sublette County, Wyoming, be described as follows:

Township 29 North, Range 113 West of the Sixth P. M.

- Section 10: E 1/2 SE 1/4
- Section 11: S 1/4
- Section 12: S 1/2 SE 1/4, NW 1/4 SW 1/4
- Section 13: N 1/2 NE 1/4, SE 1/4, SW 1/4
- Section 14: N 1/2 NE 1/4, NE 1/4 NW 1/4
- Section 24: N 1/2 NE 1/4

Township 29 North, Range 112 West of the Sixth P. M.

- Section 18: NW 1/4

IT IS FURTHER ORDERED that this Order correcting and amending the said judgment be entered Mune Pro Tune to appear of record as effective as of the 27th day of March, A. D. 1950, that being the date when said Judgment and Decree was originally made and entered.
