## AFFIDAVIT

Dorothy Johnson, of said state and county, being first duly sworn, on her oath, says:

That she is the surviving widow of R. G. Johnson, deceased, sometimes known as Robert Guy Johnson, who died March 8, 1955, in Paris, County of Logan, state of Arkansas.

That on the 27th day of June, 1950, Thomas C. Lelgado and Florence Belgado, his wife, conveyed by Warranty Deed, certain real property in the County of Sublette, State of Wyoming, hereinafter more accurately described, to R. G. Johnson and Dorothy Johnson, his wife, or the survivor thereof, described as follows, to-wit:

All of Lots Five (5), Six (6), Seven (7) and Eight (8), Block Fifteen (15), Hennick Addition to the Town of Pinedale, Wyoming as the same appears of record on the official plat thereof, filed for record in the Office of the County Clerk and Ex-Officio Register of Deeds, Sublette County, Wyoming, together with all improvements and appurtenances thereunto appertaining.

That said Warranty Deed was duly recorded, and filed for record in the Office of the County Clerk and Ex-Officio Register of Deeds, Sublette County, Wyoming, on the 31st day of August, 1950, in Book 6 of Deeds, at page 168.

That the deceased, Robert Guy Johnson, sometimes known as R. G. Johnson, is one and the same person as the R. G. Johnson, one of the grantees in the before mentioned Warranty Deed; that the affiant, Dorothy Johnson, is one and the same person as the Dorothy Johnson, the other grantee in said warranty Deed.

That on the 27th day of June, 1950, and many years previous to that time, and until his demise, the deceased, Robert Guy Johnson, sometimes known as R. G. Johnson, and the affiant, Dorothy Johnson, were husband and wife, and that the before mentioned Warranty Deed created an estate by the entireties, under the laws and the Supreme Court Decisions of the State of Wyoming, and at the death of Robert Guy Johnson, sometimes known as R. G. Johnson, deceased, all right, title and interest in the before mentioned property passed to, and was vested in Dorothy Johnson.
