

8. That under the terms and provisions of the said Last Will and Testament and Codicil thereto of the decedent admitted to probate as aforesaid Lavina Bone Campbell of Tulsa, Oklahoma, was, during her lifetime, to receive certain benefits enumerated therein from a trust created by the decedent, but that said Lavina Bone Campbell predeceased the decedent having died on October 23, 1949, and all her interests, rights and benefits under said Will and Codicil thereto terminated by reason of said death.

9. That under the terms and provisions of the said Last Will and Testament and Codicil thereto of the decedent admitted to probate as aforesaid all the above-described real property and interests therein should be distributed to Victor M. Reid, Jr., of Los Angeles, California, and Edward G. Girard of Alhambra, California, in trust, however, to hold, manage, control, accumulate and distribute for the use and benefit of Donald Edward Girard and John Baker Girard, twin sons of Edward G. Girard and Marion Baker Girard, share and share alike; that the terms and conditions of said trust and of said distribution are more specifically and fully set forth hereinafter, and that said terms and conditions are by reference made a part of this paragraph and finding.

IT IS, THEREFORE, ORDERED, ADJUDGED AND DECREED By the Court:

1. That the final account and petition for distribution filed by the said executor in the matter of the above estate and all his disbursements, acts and transactions had in the matter of said estate be, and the same are hereby, approved, ratified and confirmed.

2. That all orders of the District Court Commissioners made in the matter of the above estate be, and the same are hereby, approved and confirmed.

3. That the following named persons are hereby declared and determined to be the heirs at law and next of kin of the deceased, to-wit:

J. Thomas Bone, adult, half-brother residing at Edina, Missouri  
Ines Mullins, adult, half-sister residing at Clyde, Kansas  
James A. Campbell, adult, half-nephew residing at Tulsa, Oklahoma  
T. M. Campbell, adult, half-nephew residing at Tulsa, Oklahoma  
Paul C. Campbell, adult, half-nephew residing at Tulsa, Oklahoma

4. That the real estate and property and interests therein hereinabove described, and all the right, title and interest of the said decedent and her estate therein and thereto, and any and all other real and personal property of the deceased and her estate within the State of Wyoming, including property hereafter discovered be, and the same is hereby distributed as follows: To Victor M. Reid, Jr. of Los Angeles, California and Edward G. Girard of Alhambra, California, in trust, however, to hold, manage, control and distribute as follows: The net income from all such trust property or any part of said income shall be used by the said named trustees for the support, maintenance, education and general welfare of Donald Edward Girard and John Baker Girard, both of Alhambra, California, share and share alike; provided, that if at the end of each calendar year, there remains any unexpended net income, the same shall be accumulated by the said trustees hereinabove named, and when said Donald Edward Girard and John Baker Girard shall reach the age of twenty-one years, all income theretofore accumulated shall be transferred and paid to them share and share alike. The said trustees shall have the sole discretion as to whether said net income or any part thereof shall be used for the benefit of said Donald Edward Girard and John Baker Girard prior to their attaining the age of twenty-one years or be accumulated until such age, and if either dies before reaching the said age of twenty-one years, his share of accumulated income shall be held, as such by the trustees. The trust shall terminate on the twenty-fifth anniversary of the birth of said John Baker Girard and Donald Edward Girard, at which time the trustees shall convey and deliver the trust estate and any accumulated and/or unpaid income to them share and share alike. If either or both John Baker Girard or Donald Edward Girard fail to survive the termination of the trust, then upon the termination of the trust, it shall be disposed of as follows: (a) If one of the parties dies before termination of the trust leaving no issue surviving him, then his share of the principal and income shall go to the survivor. (b) If both die before termination of this trust, leaving no issue surviving them then upon termination of the trust
