The petition of Anna C. Christensen, praying that the Court determine the dates of death of R. W. Vickrey and Julia Vickrey, their heirs at law, their degree of kinship and the right of descent of the real property of which they died seized and possessed, and for general relief, this day coming on regularly to be heard, and proof having been made to the satisfaction of the Court and the Court finds that notice of the time and place of hearing said petition has been regularly published and given in the manner and for the time required by law, and that the descendants of said decedents have entered an appearance herein and disclaimed any interest in the real property hereinafter described; and the Court, upon hearing the evidence, oral and documentary, finds all of the allegations of said petition to be true and the prayer thereof ought to be granted.

And the Court finds, establishes and determine as follows:

a. That said R. W. Vickrey died intestate at Salt Lake City, Utah on the 3rd day of March, 1950 and was a resident of the County of Sublette, and State of Wyoming at the time of his death and the owner of the following described real property, to-wit:

The Lots Numbered eight (8), nine (9) and ten (10) in Book Numbered seventeen (17) of the C. P. MacGlashan's Addition to the Town of Big Piney, Sublette County; and State of Wyoming, as surveyed, platted and recorded.

b. That said Julia Vickrey died intestate on the 29th day of December, 1950 and was a resident of said Sublette County, and State of Wyoming, and that said R. W. Vickrey and Julia Vickrey were husband and wife, and upon the death of her said husband, by operation of law, an undivided one-half interest in said real estate vested in said Julia Vickrey and was the owner of said undivided one-half interest in said above described real property at the time of her said death.

c. And the Court further finds, establishes and determines, that said R. W. Vickrey and Julia Vickrey were husband and wife and remained such until separated by death, and that they, and each of them were survived by the following named descendants and their only heirs at law and the only persons entitled to inherit their respective estates, viz:
