NOTICE OF LIEN FOR LABOR

TO WHOM IT MAY CONCERN:

Notice is hereby given: That it is the intention of T. F. Anderson of LaBarge, Wyoming, the claimant herein, to claim and hold a lien upon that certain tract of land hereinafter described, for the sum of Seven Hundred eighty-five and 40/100 (\$785.40) Dollars, with interest thereon from July 21, 1956, at the legal rate. The said sum is due and owing to said claimant for labor performed in that certain improvement of said land described as follows, to-wit:

The Southeast Quarter of the Northeast Quarter (SE $\frac{1}{4}$ NE $\frac{1}{4}$), Section Thirty-three (33), Township Twenty-seven (27) North, Range One Hundred Thirteen (113) west, together with the entire lease interest in Township 26 North, Range 113 West, 6th P.M., Wyoming, Section 4: Lots 1 through 12, SE $\frac{1}{4}$, NW $\frac{1}{4}$ SW $\frac{1}{4}$. Township 27 North, Range 113 West, 6th P.M., Wyoming, Section 28: SE $\frac{1}{4}$ SW $\frac{1}{4}$, SW $\frac{1}{4}$ SE $\frac{1}{4}$. Section 29: SE $\frac{1}{4}$ NE $\frac{1}{4}$. Section 32: W $\frac{1}{2}$ SE $\frac{1}{4}$, N $\frac{1}{2}$ NE $\frac{1}{4}$, SW $\frac{1}{4}$ NE $\frac{1}{4}$. Section 33: NW $\frac{1}{4}$ NE $\frac{1}{4}$, S $\frac{1}{2}$ NE $\frac{1}{4}$, NW $\frac{1}{4}$, SE $\frac{1}{4}$.

That the names of the persons for whom and at whose request said labor was performed are E. J. Anderson Drilling Company and Vaughan B. Connelly.

That the first item of said labor was performed on the 18th day of June, 1956, and the last item thereof on the 21st day of July, 1956.

That the description of said land and premises upon which said improvement was made, and which is to be charged with said lien, and which is situate in the County of Sublette, State of Wyoming, is as follows, to-wit:

That certain tract of land described as follows: the Southeast Quarter of the Northeast Quarter (SE $\frac{1}{4}$ NE $\frac{1}{4}$), Section Thirty-three (33), Township Twenty-seven (27) North, Range One Hundred Thirteen (113) West, being the drilling location, together with all oil derricks, oil tanks, pipe, oil and gas pipe lines, and any other material and equipment used in and about said premises together with the equity in the entire lease covering Township 26 North, Range 113 West, 6th P.M., Wyoming, Section 4: Lots 1 through 12, SE $\frac{1}{4}$, NW $\frac{1}{4}$ SW $\frac{1}{4}$. Township 27 North, Range 113 West, 6th P.M., Wyoming, Section 28: SE $\frac{1}{4}$ SW $\frac{1}{4}$, SW $\frac{1}{4}$ SE $\frac{1}{4}$. Section 29: SE $\frac{1}{4}$ NE $\frac{1}{4}$. Section 32: W $\frac{1}{2}$ SE $\frac{1}{4}$, N $\frac{1}{2}$ NE $\frac{1}{4}$, SW $\frac{1}{4}$ NE $\frac{1}{4}$. U. E., 2 3/8 inch tubing and pup joints, 6 foot National working barrel, all 5 1/2 inch casing, all 8 5/8 inch casing, all 9 5/8 inch casing, 1 National pump jack with Wisconsin motor, 1 V-8 Ford 1956 Custom-line Fordor sedan, License No. Wyoming 12-2640, all storage tanks with oil therein and flow lines, and 1 wooden dog house.

That the owner of the lease of said land and premises, at the date of making this notice, according to the best information, this claimant now has or is able to obtain, is Vaughan B. Connelly, the owner of the drilling equipment and other material is E. J. Anderson, and Vaughan B. Connelly.

The Post Office Address of the Claimant is LaBarge, Wyoming.

T. F. Anderson, being duly sworn on oath says that he is the claimant in the foregoing notice; that he has knowledge of the facts stated in said notice by reason of the following facts, to-wit: That he was hired by E. J. Anderson, to work upon the drilling rig as derrick man, at the standard rate of pay being \$2.10 per hour, that he worked 200 hours at the rate of \$2.10 per hour and a total of 116 hours overtime at the overtime scale of time and one-half, being a total of \$3.15 per hour, thus having a total wage due him of \$785.40, and that the statement is true of his own knowledge and this lien is filed in accordance with the Wyoming labor law and that demand has been made for payment and payment refused.
