DECREE OF SETTLEMENT OF FINAL
ACCOUNT AND DISTRIBUTION.

VIOLA McGINNIS, as administratrix of the estate of Frank R. McGinnis, deceased, having on or before the 17th day of August, 1956, rendered and filed in the above entitled court and proceeding a full and true account and report of her administration of the estate of said decedent, which account was for a final settlement, and having filed therewith a petition for distribution of said estate, and said account and report coming on regularly for hearing before the Court, proof having been made to the satisfaction of the Court that due and legal notice thereof has been given to the creditors and other persons interested in said estate in the manner and substance required by law, by publication of notice in the Kemmerer Gazette, a weekly newspaper regularly printed and published at Kemmerer, in Lincoln County and State of Wyoming, and of general circulation, for four successive weeks commencing with the issue of July 19, 1956, and copies thereof mailed to the heirs of said decedent. And

There being no one appearing in opposition or objecting thereto, and it appearing of record herein that by an order of this Court made and entered herein on the 13th day of December, 1955, Viola McGinnis was appointed administratrix of the estate of said decedent and thereafter duly qualified as such and Letters of Administration duly issued to her by the clerk of this court on December 14, 1955; that she thereupon gave notice to the creditors of said deceased in the manner and substance provided by law to present to her or file with the clerk of said court their claims within six months from December 15, 1955, the date of the first publication of said notice to creditors, and the time stated herein and limited by law for presenting and filing such claims has now expired; that all costs, charges and expenses of the administration of said estate, including attorney fees, and all taxes levied and assessed against said estate have been fully paid and discharged; that no inheritance tax is chargeable in said estate and the filing of a certificate of the Inheritance Tax Commissioner is excused; that said administratrix has duly made and returned to this court and filed with the clerk thereof a true inventory and appraisement of said estate, and that said estate has now been fully administered and in condition to be closed and the residue thereof distributed to the person or persons entitled thereto; and the Court, having fully considered the matter and proceedings herein had and the evidence adduced, finds;

That the final account of said administratrix to be true and correct; and is hereby approved.
