

the Last Will and Testament of Grace Alexander, deceased, for the reason that said Testatrix was incompetent and lacked the necessary testamentary capacity to make a valid disposition of her property, and further that said Testatrix was the subject of undue influence exerted by Lawrence William Alexander, and it appearing that thereafter the said Earl Eugene Alexander did file herein his written stipulation withdrawing his objections and dismissing the same with prejudice, and consenting to the probate of decedent's Last Will and Testament, and in consideration thereof Charles Herbert Alexander and Lawrence William Alexander did quitclaim, convey and release unto Earl Eugene Alexander all of their right, title, interest and equity as residuary legatees and devisees under the Last Will and Testament of Grace Alexander, deceased, unto Earl Eugene Alexander, in and to the following described real estate:

Lots Fifteen (15) and Sixteen (16) in Block Twenty (20) of the Hennick Addition to the Town of Pinedale, Sublette County, Wyoming.

and accordingly said real estate should be set over, distributed and transferred unto Earl Eugene Alexander as his absolute property;

And it further appearing to the Court that there are no inheritance taxes owing to the State of Wyoming from said estate and that said estate is ready for distribution and in condition to be closed, and that by the terms of the Last Will and Testament of Grace Alexander, deceased, she did bequeath and devise the entire residue of her estate unto her two sons, Lawrence William Alexander and Charles Herbert Alexander, in equal shares, and that Lawrence William Alexander died on the 24th day of June, 1955 and that George A. Moffat is the duly appointed, qualified and acting Administrator of the estate of Lawrence William Alexander, deceased, and as said Administrator should have distributed unto him one-half of the remainder and residue of the estate of Grace Alexander, deceased, for further distribution to those thereto entitled, and that the remaining one-half of the estate of Grace Alexander, deceased, should be distributed and set over unto Charles Herbert Alexander as his absolute property;

Now therefore on the petition of George A. Moffat, Administrator with the Will Annexed of the Estate of Grace Alexander, deceased, and no objections being made thereto, it is hereby,

CONSIDERED, ORDERED, ADJUDGED AND DECREED that the said Report of Administrator filed herein on the 30th day of April, 1957, be, and the same is hereby approved, allowed and settled;

And it is further CONSIDERED, ORDERED, ADJUDGED AND DECREED by the Court that all of Lots Fifteen (15) and Sixteen (16) in Block Twenty (20) of the Hennick Addition to the Town of Pinedale, Wyoming be, and the same are hereby set over, transferred, and distributed to and vested in Earl Eugene Alexander, as his absolute property, and
