A 5 1/2% royalty interest in all oil and gas produced from SW_{1/4}NE_{1/4}, SE_{1/4}SE_{1/4}, W_{1/2}SE_{1/4} of Section 32; NE_{1/4}SW_{1/4}, W_{1/2}SW_{1/4}, SE_{1/4}SW_{1/4}, NW_{1/4}SE_{1/4}, S_{1/2}SE_{1/4}, in Section 33, SE_{1/4} in Section 29, all in Township 25 North, Range 3 West, Teton County, Montana, and containing 600 acres more or less, the same being that interest, less 1% assigned to Worth Garetson from Clarence A. Carlson and Marinda J. Carlson, his wife, June 8, 1944 and recorded in Book 22 of Deeds, Page 311, Teton County, Montana. Any proceeds therefrom shall be distributed as follows: 1/2 thereof to Bama M. Garetson, 1/4 thereof to each of Mary Frances Christopher and Jean Cronberg.

A 5 1/2% royalty interest in all oil and gas produced from W_{1/2}SE_{1/4}, N_{1/2}SW_{1/4} of Section 28, E_{1/2}NW_{1/4}, W_{1/2}NE_{1/4} of Section 33, all in Township 25 North, Range 3 West, Teton County, Montana, and containing 320 acres more or less, the same being that interest less 1% assigned to Worth Garetson from Ernest W. Carlson and Evelyn V. Carlson, his wife, June 8, 1944, and recorded in Book 22 of Deeds, Page 312, Teton County, Montana. Any proceeds therefrom shall be distributed as follows: 1/2 thereof to Bama M. Garetson, 1/4 thereof to each of Mary Frances Christopher and Jean Cronberg.

A 3 1/8% royalty interest in all oil and gas produced from NW_{1/4}, N_{1/2}SW_{1/4}, SE_{1/4}SW_{1/4} of Section 29, NE_{1/4}NW_{1/4} of Section 32, all in Township 25 North, Range 3 West, Teton County, Montana, and containing 320 acres more or less, the same being that interest assigned to Worth Garetson by Gurine Miller, a widow, July 15, 1944, and recorded in Book 22 of Deeds, Page 360, Teton County, Montana. Any proceeds therefrom shall be distributed as follows: 1/2 thereof to Bama M. Garetson, 1/4 thereof to each of Mary Frances Christopher and Jean Cronberg.

A 1% royalty interest in all oil and gas produced from W_{1/2}NW_{1/4}, SE_{1/4}NW_{1/4}, NE_{1/4}SW_{1/4}, Section 32, Township 25 North, Range 3 West, Teton County, Montana and containing 160 acres more or less, the same being that interest assigned to Worth Garetson by George Coffey and Marie Coffey, his wife. Any proceeds therefrom shall be distributed as follows: 1/2 thereof to Bama M. Garetson, 1/4 thereof to each of Mary Frances Christopher and Jean Cronberg.

A 1% royalty interest in all oil and gas produced from the N_{1/2} of Section 28, Township 25 North, Range 3 West, Teton County, Montana and containing 320 acres more or less, the same being that interest assigned to Worth Garetson by George Coffey and Marie Coffey, his wife. Any proceeds therefrom shall be distributed as follows: 1/2 thereof to Bama M. Garetson, 1/4 thereof to each of Mary Frances Christopher and Jean Cronberg.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the Administrator be, and he is hereby, authorized and directed to endorse, transfer, assign and set over unto the persons mentioned above and in the same proportions all of the negotiable instruments, securities, judgements, contracts of sale, choses of action, royalty interests, real and personal property as may be necessary.
