Grant of Easement

George Milleg and Lillian Violet Curtis Milleg, husband and wife, of Sublette County, Wyoming, for and in consideration of the sum of Ten (\$10.00) Dollars, receipt whereof is hereby acknowledged, have granted and by these presents do grant unto the Town of Big Piney, a municipality in the County of Sublette, State of Wyoming, a right of way for all purposes upon, over and across the lands hereinafter described:

That part of the SE<sub>1</sub> NW<sub>1</sub> and SW<sub>1</sub> NE<sub>1</sub> of Section 36, T30N, R112W, 6th P.M. Sublette County, Wyoming, described as follows: Beginning at a point on the east-west mid-section line of said Section 36 which is N87°-34'W, 251.9 ft. from the center of said Section 36 where found a granite stone set in concrete 8" x 8" x 24" marked "CENT. S. 36" on north side, "BP" and "S" on south side, and "4" on top; thence N26°-06'E, 570.8 ft. to a point on the north-south mid-section line of said Section 36 which point is N00°-06'W, 523.3 ft. from the center of said Section 36; thence N26°-06'E, 98.3 ft. to a point on the south right-of-way line of state secondary road S-98; thence N60°-09'W, 50.0 ft. along said right-of-way line to a brass marker set in a 6" x 6" concrete post inscribed "STATE HIGHWAY R-O-W Sta. Corp. Limit El. 6846.58"; thence S00°-06'E, 17.2 ft. to a brass marker set in a 6" x 6" concrete post inscribed "STATE HIGHWAY R-O-W Sta. Corp. Limit El. 6847.26"; thence S26°-54'W, 679.5 ft. to a point on the east-west mid-section line of said Section 36; thence S87°-34'E, 56.6 ft. along said mid-section line to the point of beginning; each point being marked by a steel T-shaped stake 24" long set in concrete with brass cap inscribed "SURVEY POINT DO NOT DISTURB RLS164."

TO HAVE AND TO HOLD said right-of-way for all purposes unto the Town of Big Piney, its successors and assigns forever.

The rights, privileges and easement herein granted shall be appurtenant to lands and real estate now owned and held by the Town of Big Piney, and adjoining the lands hereinabove described, said lands so owned and held by the Town of Big Piney being situate partly within the corporate limits of the Town of Big Piney, Sublette County, Wyoming, and partly situate in the SE<sub>1</sub> NW<sub>1</sub> Section 36, Township 30 North, Range 112 West of the 6th P. M., Wyoming.

By the acceptance hereof it is expressly agreed and understood by the grantee, Town of Big Piney, that the rights, privileges and easement herein granted shall be exercised in common with Robert L. Miller and Mildred M. Miller, husband and wife, and their heirs and assigns, and shall be subject to the common exercise of similar rights, privileges and easement by Robert L. Miller and Mildred M. Miller, husband and wife, and their heirs and assigns.
