DECREE OF SETTLEMENT OF ACCOUNT AND FINAL DISTRIBUTION

Leo L. Baker, administrator of the Estate of Grace Bentley, deceased, having on or about the 23rd day of July, 1948, rendered and filed herein a full account and report of his administration of said estate, which account was for final settlement, and having with said account filed a petition for the final distribution of said estate;

And said account and petition this day coming on regularly to be heard, proof having been made to the satisfaction of the Court that Notice of the Settlement of said account and hearing of said petition has been given in accordance with the laws of the State of Wyoming, and that proof thereof has been filed herein;

And it appearing that said account is in all respects true and correct and that all claims filed in said estate and all debts of decedent, all taxes on said estate, including inheritance taxes and all debts, expenses and charges of administration, except as hereinafter stated, have been fully paid and discharged, and that said estate is ready for distribution; that the court costs amount to and are taxed at \$ none.

And the Court finds that on August 27, 1931, first publication of notice to creditors of said estate was published and thereafter said publication was continued for the time and in the manner provided by law, proof of which publication was filed with the Clerk of this Court, and the Court finds that an Inventory and Appraisement of said estate was made and filed herein by said administrator. AND THE COURT FINDS:

That the only property on hand at this time for distribution is interest in Lot 13, Block 15; Hennick Addition to the Town of Pinedale; that heretofore on the 18th day of May, 1932 all of the heirs of the said Grace Bentley, deceased, conveyed said lot to Walter W. Scott by Quit Claim Deed, who in turn conveyed said lot to M. J. Murphy and Esther E. Murphy, his wife; that the heirs at law of the said Grace Bentley are George G. Bentley, Anson B. Bentley, Sarah E. Allen, Joseph R. Dunham, and Gertrude Baker, children, all over the age of 21 years.

AND THE COURT being advised in the premises, it is Ordered, Adjudged and Decreed that the said Final Account of Leo L. Baker, administrator, filed herein, be and the same is ordered settled, allowed and approved, and that the residue of said estate hereinafter particularly described be distributed as follows, to-wit:

TO M. J. Murphy and Esther E. Murphy, his wife, all interest in Lot 13, Block 15; Hennick Addition to the Town of Pinedale, as the same appears of record on the official plat thereof on file in the office of the County Clerk at Pinedale, Sublette County, Wyo. That the residue, if any, be distributed to the above named children equally.

IT IS ORDERED, ADJUDGED AND DECREED by the Court that said estate be distributed as hereinabove stated and the trust be closed.
