STATEMENT OF MECHANIC'S LIEN

The undersigned claimant, R. O. Shamp doing business as Electric Center of Evanston, Uinta County, Wyoming, makes the following statement under the provisions of Chapter 55, Article 2, Wyoming Compiled Statutes 1945, for a mechanic's lien for materials, furnished, and labor and services furnished and performed on buildings situated on the following described lands in Sublette County, Wyoming, to-wit:

That part of the Northeast Quarter of the Northeast Quarter, Section Thirty-one, Township Thirty North, Range One Hundred Eleven West of the 6th Principal Meridian, Sublette County, Wyoming, described as follows: Beginning at a point S. 48°, 46' W., 1118.0 ft. from the Northeast corner of Section 31, T. 30 N., R. 111 W.; Thence S. 000°, 24' W., 537.4 Ft. to a point on the South line of said NE $\frac{1}{4}$ NE $\frac{1}{4}$, which point is also N. 87°, 00' W., 842.2 ft. from the Southeast corner of said NE $\frac{1}{4}$ NE $\frac{1}{4}$; thence N. 87°, 000' W., 420.0 ft. along said South line to the point of intersection with the east right-of-way line of Highway No. 189; thence N. 00°, 21' E., 518.0 ft. along said east right-of-way line to a point which is S. 59°, 46' from the northeast corner of said section 31; thence S. 89°39' E., 420.0 ft to the point of beginning; containing an area of 5.085 acres, more or less.

That on or about the 17th day of January, 1958, claimant entered into an oral contract with Willie Osterkamp and Arline Osterkamp, of Big Piney, Sublette County, Wyoming, wherein and whereby claimant agreed to furnish the materials at retail price, plus sales tax, and the labor at \$4.25 per hour, for wiring 3 quonset-type buildings belonging to said Willie Osterkamp and Arline Osterkamp hereinafter designated as owners, and to do the plumbing in two of said buildings, all buildings being situated on the premises above described.

That all the necessary materials were furnished and the labor and services furnished and performed, and the said contract completed on or about the 5th day of April, 1958, to the satisfaction of the owners.

That a true and correct statement of the charges for said materials and labor, showing all credits allowed thereon, is attached hereto marked Exhibit "A" and by reference made a part hereof as if set out herein in full; that there is due and owing to the claimant from the owners the full sum of \$2088.99 for the furnishing of said materials, labor and services as aforesaid after allowing all just credits, deductions and set offs, all of which balance, with interest thereon at the legal rate from the date of the completion of the contract, is still due and unpaid;

And the claimant claims a lien upon the lands above described, and the improvements and appurtenances thereon for the amount of his claim, being \$2,088.99, plus interest, according to the statute in such case made and provided.
