DECREE OF FINAL SETTLEMENT OF ACCOUNT

And the Court, having examined said Final Account and Petition for Distribution, the Supplemental Account and Report, the Inventory and Appraisement herein filed and the Amended Inventory and Appraisement herein filed, and all other records and instruments herein filed and having heard all of the evidence submitted, and being now sufficiently advised in the premises, finds that the whole of said estate, which is now in the possession and under the control of said Administrator, and which is ready for distribution, consists of real and personal property, described as follows, to-wit:
