JUDGMENT

This cause, pending on appeal from the State Board of Control, of the State of Wyoming, came on this 20 day of July, 1958, to be heard by the Court, upon the Pleadings herein filed, by the Contestant and Plaintiff and the Contestee and Defendant, and upon the Stipulation of said parties, signed and filed herein, and upon the evidence submitted,

And the parties hereto appearing by their respective attorneys, and having, by their said Stipulation, stipulated and agreed that this Court make and enter herein, a Judgment in favor of Plaintiff and against Defendant, in accordance with said Stipulation herein filed, and the Court being now sufficiently advised in the premises,

IT IS HEREBY ORDERED, that said Stipulation be, and the same is hereby approved and confirmed.

IT IS, THEREFORE, ORDERED, ADJUDGED AND DECREED that the prayer of the Plaintiff's Answer and Objections be, and the same is hereby granted.

IT IS FURTHER ORDERED, ADJUDGED, AND DECREED, that the decision of the State Board of Control, of the State of Wyoming, in relation to Water and Water Rights for irrigation purposes, in connection with the NE1/4 of Section 20, Township 38 N., Range 113 West, from Dell Creek, tributary of Hoback River, through Stults Ditch and the enlargement thereof, under Permit Number 4393 E., for the irrigation of said land, be, and the same is hereby sustained and affirmed.

IT IS FURTHER ORDERED, ADJUDGED, AND DECREED, that the decision of said State Board of Control and its findings and Order, dated November 21, 1956, wherein said State Board of Control denied the Petition of Plaintiff and granted and allowed 0.43 cubic foot of water for domestic use, in connection with said tract of land, be and the same is hereby reversed.
