JUDGMENT

THIS MATTER having come on regularly for trial this *15th* day of September, 1958, before the Honorable H. R. Christmas, Judge of the District Court, Third Judicial District, and all of the defendants having made their general appearance herein and having filed their answer herein by way of general denial; that all of the defendants, by their attorney, Lawrence A. Marty, and the plaintiff, by its attorney, Robert W. Sievers, have filed herein their stipulation for judgment, stating that the differences between the parties have been in all respects settled and adjusted, with the exceptions as to the definition of the shallow rights and the plaintiff having withdrawn without prejudice that part of its demand for judgment covering a two per cent overriding royalty of the shallow rights, and the Court being fully advised in the premises, the Court finds as follows:

1. That the plaintiff, Belfer Natural Gas Company, a partnership, is the owner of a good and valid oil and gas lease from Joseph A. Minton and Bessie B. Minton, husband and wife, covering the N $\frac{1}{4}$ SW $\frac{1}{4}$, SW $\frac{1}{4}$ SW $\frac{1}{4}$, NW $\frac{1}{4}$ SE $\frac{1}{4}$, Section 28, Township 27 North, Range 113 West, reserving therein unto the lessors all rights to
