Larson, receiver of the Bank of Paullina, Iowa, covering the NW $\frac{1}{4}$  SW $\frac{1}{4}$ , SW $\frac{1}{4}$  SE $\frac{1}{4}$ , Section 28, Township 27 North, Range 113 West, reserving therein to the lessor all rights to oil, gas, casinghead gas and all other minerals from the surface of the earth down to a depth of 1500' above the top of the Frontier Formation, dated June 11, 1957, and filed for record in Book 17 Oil and Gas, page 2, in the office of the County Clerk, Sublette County, Wyoming.

2. That the said leases and overriding royalties herein - after specifically set forth be, and the same are, quieted against any and all claims, demands or pretensions of said defendants, and each of them, to any right, title, interest, or estate of any kind.

3. That the defendants, and each of them, be and they hereby are, forever enjoined and debarred from setting up any right, title, interest, or estate whatsoever in said leases and in said lands below shallow depths, as hereinabove specifically defined, and to said oil and gas and other hydrocarbon substances or in any part thereof.
