7. That the last will and testament of Dudley Kent Bowen, also known as Dudley K. Bowen and D. K. Bowen, deceased, admitted to probate herein, provides, among other things, as follows:

"IN THE NAME OF GOD, AMEN, I, Dudley Kent Bowen being of sound mind and memory, but knowing the uncertainty of human life, do now make and publish this my last will and testament, that is to say: I give, devise and bequeath all my property both real and personal to my beloved wife Mabel Elveta Bowen, and appoint her executrix to serve without bond."

and that said Mabel Elveta Bowen, is, therefore, under the terms and provisions of said last will and testament, entitled to have all of the above described residue and remainder of said estate distributed, conveyed and set over to her.

IT IS, THEREFORE, ORDERED, ADJUDGED AND DECREED that the said final account of said executrix be, and the same is hereby, settled, allowed and approved, and that the residue of said estate hereinbefore particularly described, and any other property not known or discovered, and which may belong to said estate, or in which said estate may have an interest, be and the same is hereby, distributed, granted, conveyed and set over as follows:

To Mabel Elveta Bowen, of Rock Springs, Wyoming, all of the residue and remainder of the said estate to have and to hold the same unto herself, her heirs and assigns forever.
