DECREE OF FINAL SETTLEMENT OF ACCOUNT AND
ORDER OF DISTRIBUTION

James P. Youngberg, Administrator of the Estate of Ralph J. Buxton, deceased, having on the 26th day of April, 1960, filed in this Court, his Final Account and Petition for Distribution, setting forth among other matters, that his administration accounts have been finally settled, and that said estate is in a condition to be closed, and that the residue and remainder of said estate remains to be distributed and decreed to the heirs at law of Ralph J. Buxton, deceased, as is provided by the statute and rule of descent, in such case made and provided.

And this matter coming on regularly to be heard this 13 Day of May, 1960, upon the Final Account and Petition for Distribution and upon the records, proofs and other instruments filed herein, and it appearing to the Court from the proof of publication filed herein, that Notice of Final Settlement has been published for the time and in the manner provided for by law, and that proof of publication thereof has been filed herein, and that copies of said Notice of Final Settlement of said estate have been mailed to said heirs and to all the known heirs of said decedent, and that the Affidavit of mailing said Notice has been filed herein, as provided by statute.

And the Court having examined said Final Account and Petition for Distribution, the Inventory and Appraisement herein filed, and all other records and instruments herein filed, and having heard all of the evidence submitted, and being now sufficiently advised in the premises, finds that the whole of said estate, which is now in the possession and under the control of said Administrator, and which is ready for distribution, consists of real and personal property, described as follows:

REAL PROPERTY
