

thence from said initial point South 300 feet to a point; thence West 300 feet; thence North 300 feet to a point; thence East 300 feet to said initial point, the place of beginning, containing 2.066 acres.

B. A tract of land conveyed to M. M. Baker, March 3, 1931, described as follows: Beginning on a point which is 666 feet South of a point which is 1373 feet East of the Northwest corner, Section 2, Township 33 North, Range 111 West (the said initial point being 140 feet North of the Northeast corner of a tract of land owned by E. D. Key) and running thence East 280 feet; thence South 140 feet; thence West 280 feet; thence North 140 feet to point of beginning.

C. A tract of land conveyed to Blackmon and Son, July 15, 1930, described as: Beginning on a point which is 1106 feet South of a point which is 1373 feet East of the Northwest corner, Section 2, Township 33 North, Range 111 West (the said initial point being 300 feet South of Northwest corner of a tract of land owned by E. D. Key) and running thence East 200 feet; thence South 50 feet; thence West 200 feet; thence North 50 feet to point of beginning, containing 0.2295 acres, more or less.

D. A tract of land conveyed to the Sublette County Historical Society, December 27, 1937, described as: Beginning at a point which is 1374½ feet South 89°59' East of the Northwest corner of Section 2, Township 33 North, Range 111 West; thence South 89°59' East along State Highway right of way 36½ feet; thence North 0°04' West along State Highway right of way 330 feet; thence East 660 feet; thence South 235 feet; thence South 77°20' West 100 feet; thence South 73°45' West 90 feet; thence South 58°16' West 100 feet; thence South 42°34' West 90 feet; thence South 90 feet; thence South 44°46' West 100 feet; thence South 87°49' West 189.8 feet; thence North 58°42' West 124 feet, to State Highway right of way; thence North 0°04' West along State Highway right of way 174 4/5 feet to the point of beginning containing 6.63 acres of land, be there more or less.

E. A tract of land conveyed to Walter F. Yarger and Susie Yarger, his wife, June 28, 1930, described as: Beginning on a point which is 566 feet South of a point which is 1373 feet East of the Northwest corner, Section 2, Township 33 North, Range 111 West (the said initial point being 240 feet North of the Northwest corner of a tract of land owned by E. D. Key) and running thence East 200 feet; thence South 100 feet; thence West 200 feet; thence North 100 feet to point of beginning, containing 0.459 acres, more or less.

F. A tract of land conveyed to W. F. Yarger, July, 1940, described as: Beginning on a point which is 566 feet South of a point which is 1573 feet East of the Northwest corner, Section 2, Township 33 North, Range 111 West (the said initial point being on the Northeast corner of a rectangular shaped parcel of land extending 200 feet East and West and 100 feet North and South and owned by W. F. Yarger) and running thence East 80 feet; thence South 100 feet; thence West 80 feet; thence North 100 feet to the point of beginning.
