

EXHIBIT "B"

Tract No. 1

The Southeast Quarter of the Northwest Quarter, the North Half of the Northeast Quarter, the Southwest Quarter of the Northeast Quarter, the West Half of the Southeast Quarter and the Southeast Quarter of the Southeast Quarter of Section 23, and the Northeast Quarter of the Northeast Quarter of Section 26, all in Township 38 North of Range 113, West of the Sixth Principal Meridian, Wyoming, containing 320 acres, more or less.

Tract No. 2

The Northeast Quarter; Southeast Quarter of the Northwest Quarter; Northeast Quarter of the Southwest Quarter; North Half of the Northwest Quarter; Southwest Quarter of the Northwest Quarter; and the Northwest Quarter of the Southwest Quarter; all in Section 21; and the West Half of the Northwest Quarter of Section 22, all in Township 38 North, Range 113 West of the Sixth Principal Meridian, Wyoming.

Excepting and Reserving therefrom the following described tract of land in the Southwest Quarter of the Northwest Quarter of Section 21, Township 38 North, Range 113 West of the Sixth Principal Meridian, Wyoming, as follows:

Beginning at the Southwest corner of the Southwest Quarter of the Northwest Quarter of Section 21, Township 38N Range 113 West of the Sixth Principal Meridian, Wyoming, and running in a northerly direction 300' to a point on the Westerly line of said Southwest Quarter of the Northwest Quarter of Section 21, Township 38N Range 113 West of the Sixth Principal Meridian, Wyoming; thence at right angles in an easterly direction 200' to a point; thence at right angles in a southerly direction 300' to a point; thence at right angles in a westerly direction 200' to the point of beginning.

Tract No. 3

The Northeast Quarter, and the East Half of the Northwest Quarter of Section 22; and the West Half of the Northwest Quarter of Section 23; all in Township 38 North, Range 113 West of the Sixth Principal Meridian, Wyoming. Together with and including all water and water rights, all ditches and ditch rights, and all improvements and appurtenances located thereon or belonging thereto.

Excepting and Reserving therefrom approximately one acre of land described as follows: Beginning at corner No. 1 (identical with the northeast corner of the Northwest Quarter Northwest Quarter Section 23, Township 38 North, Range 113 West, Sixth principal Meridian, Wyoming,) thence South following the Quarter Quarter Section line 208' to corner No. 2; thence west 208' to corner No. 3; thence North 208' to corner No. 4 (a point on the Section line); thence East following the Section line 208' to corner No. 1, the place of beginning, together with the right of ingress to and egress from said acre along the east 15' of the Northwest Quarter of the Northwest Quarter of said Section 23, but with the right of grantees herein and their successors to go upon said acre for the purpose of maintaining their irrigation ditches should said ditches intersect the said acre.
