Korfanta, to me personally known, who being by me duly sworn, did say that he is President of the Board of Trustees of School District No. 1, Sublette County, Wyoming, a municipal corporation, and that the said corporation owns certain lands described as follows: That part of the W/2SW/4 of Section 34, T34N, R109W Sublette County, Wyoming described as follows: Beginning at a point that is North, 70.0 ft. from the northeast corner of Lot 8 of Block 5 of the Hennick Second Addition to the Town of Pinedale; thence North, 550 ft.; thence West, 695 ft.; thence South, 550 ft.; thence East, 695 ft. to the point of beginning; containing an area 8.772 acres, more or less; of record in the Office of the Clerk of Sublette County, Wyoming in Book 9 of Deeds on page 294 and being identical with Block 24 of the Cooley Fifth Addition herein described; and that the seal affixed to the above dedication is the corporate seal of the said corporation and that said dedication was signed and sealed in behalf of said corporation by authority of its Board of Trustees and said Albert F.
