That after all just credits have been given Franco, there is now due to Mannix from Franco and United, on account of said work and labor performed, and equipment furnished, under said sub-contract and lease agreement, as aforesaid, the just and true sum of Twenty Thousand Three Hundred Fourteen and 80/100 (\$20,314.80) Dollars, together with interest at the rate of seven per cent (7%) per annum from October 5, 1961, on \$20,314.80, due upon said sub-contract and lease agreement.

That said indebtedness under said sub-contract and lease agreement accrued on the 5th day of September, 1961; that ninety (90) days have not elapsed since said indebtedness accrued, and since the requirements of said sub-contract and lease agreement were fully performed and completed.

That Mannix has filed this statement for the purpose of claiming, having, holding and giving notice of, a lien upon the above described right-of-way and the land occupied thereby, upon the railroad, buildings and improvements located upon the same, and upon the plant site and buildings and improvements thereon, for the aforesaid sum of \$20,314.80, together with interest thereon at the rate of 7% per annum as aforesaid, under the provisions of Title 29 and Article 6 of Chapter 7 of Title 37, Wyoming Statutes, 1957.


