The final account and report, and petition for allowance of fees, and for distribution herein, of James Folger McNamara, as executor of the estate of said deceased, by Risse, McFarland & Schnoebelen, his attorneys, coming on this 26th day of February, 1962, for hearing and settlement by the Court, all notices of said hearing having been given as required by law, the Court, after hearing the evidence, and finding that all inheritance taxes and all personal property taxes due and payable by said estate have been paid, settles said account, approves said report, and orders distribution of said estate as follows:

It is Ordered, Adjudged and Decreed by the Court that due notice to the creditors of said deceased has been given; that said executor has in his possession belonging to said estate, after deducting the credits to which he is entitled, a balance of \$14,919.06, of which \$9,191.06 is in cash, and the remainder consists of the property hereinafter described, at the value of the appraisement, and that said account and report is hereby approved, allowed and settled accordingly; that the sum of \$652.74 is hereby allowed to said attorneys as statutory fees; that said executor is hereby authorized to retain the sum of \$15.00 for necessary closing expenses; and that in pursuance of and according to the provisions of the last will of said deceased, the residue of cash, and the property hereinafter described, and all other property belonging to said estate, whether described herein or not, be and are hereby distributed as follows:

To said executor, James Folger McNamara, the following:

The sum of \$1,000.00; one-half thereof to be used for Masses for the repose of the soul of decedent, Joseph Francis Mueller, and one-half thereof to be used for Masses for the repose of the soul of Grace Margaret Mueller, deceased wife of decedent.

The sum of \$1,500.00; \$500.00 thereof to be distributed to the Sisters of the Blessed Virgin Mary, San Jose, California, for a memorial or substitute in remembrance of Grace Margaret Mueller, deceased wife of decedent; \$400.00 thereof to be distributed to the Presentation Sisters, Los Angeles, California, to be used for a memorial or substitute in remembrance of said deceased wife of decedent, and \$600.00 thereof to be distributed to the Church of St. Leo The Great, San Jose, California, to be used for a memorial or substitute in remembrance of said deceased wife of decedent.

To Theresa McNamara, sister of decedent:

Citizens National Trust and Savings Bank of Los Angeles, Certificate No. 469 - Trust 2000, Certificate of Beneficial Ownership and Interest, Glen-Donald Apartments (in Los Angeles, Calif.) representing an undivided 4900/629530 beneficial interest with exclusive and permanent right of occupancy of Apartment No. 109.
