W I T N E S S E T H :

That for a term commencing on September 1, 1964, and ending October 15, 1972, and upon all the terms and conditions set forth in that certain written lease agreement bearing date OCTOBER 8, 1962, from Lessor to Lessee, all of which terms and conditions are hereby made a part hereof, as fully and completely as if herein specifically set out in full, Lessor has leased, demised and let, and does hereby lease, demise, and let, unto Lessee, the following described real property, situate, in the Town of Pinedale, Sublette County, Wyoming, more particularly described as follows, to-wit:

The SW $\frac{1}{4}$ of Block Two (2) in the Cooley First Addition to the Town of Pinedale, Sublette County, Wyoming, more particularly described as that tract of land embraced within and bounded by survey, the initial point whereof is the SW corner of Block 2 in the Cooley First Addition to the Town of Pinedale, Wyoming, from which initial point proceed East along the South line of said Block 2 for a distance of 125 feet to a point; thence proceed North for a distance of 125 feet to a point; thence proceed West for a distance of 125 feet to a point; thence proceed South along the West line of said Block 2 to the point of beginning.
