

CERTIFICATE OF SURVEYOR

I, Paul N. Scherbel of Big Piney, Wyoming hereby certify that this map was made from notes taken during an actual survey made by me on 28 August and 11 September 1961 and that it correctly represents the FEAR ADDITION to the Town of Big Piney, being part of the SW1/4 SE1/4 of Section 31, T30N, R11W, as marked on the ground during said survey and is more particularly described as follows:

Beginning at a point $N37^{\circ}50'E$, 1239 ft. from the south one-quarter corner of the said Section 31 where is found a quartzite stone 7" x 9" x 12" mark 1+4 on top, S on NE with pits E and W; thence $S87^{\circ}05'E$, 460.9 ft. to a point on the west right-of-way line of Highway 189, thence $N00^{\circ}21'E$, 300.0 ft. to the north line of the said SW1/4 SE1/4; thence $N87^{\circ}03'W$, 56.8 ft. to a point; thence $N87^{\circ}03'W$, 460.9 ft. along the said north line to a point which is the northeast corner of a tract of land belonging to the Lincoln Service Corporation of record in the Office of the Clerk of Sublette County on page 335 of Book 2 of Quitclaim Deeds; thence $S00^{\circ}21'W$, 300.3 ft. along the said Corporation land to the point of beginning which is the southeast corner of the said Corporation land; and is identical with the tract of land conveyed by Josephine O. Guio to Clifton Fear of record in the Office of the Clerk of Sublette County in Book 5 of Deeds on page 171 less that previously conveyed to Lincoln Service Corporation; containing an area of 3.565 acres, more or less; and each point being marked by a steel T-shaped 24" long with a brass cap inscribed "SURVEY POINT DO NOT DISTURB RLS164".


