SEVERANCE AGREEMENT

WHEREAS Wayne L. Feltner Pinedale, Wyoming COUNTY OF Sublette STATE OF Wyoming
(NAME OF BORROWER) (ADDRESS)

HEREINAFTER CALLED THE "BORROWER" HAS APPLIED TO THE COMMODITY CREDIT CORPORATION FOR A
LOAN OR FOR THE GUARANTEE OF A LOAN FOR THE PURPOSE OF PURCHASING AND ERECTING OR CONSTRUCTING THE FOLLOW-
ING STORAGE STRUCTURES, TO-WIT:

TYPE Storage Tank KIND (WOOD, STEEL, ETC.) Steel CAPACITY (BUSHELS OR TONS) 1650 bushels

(amount of loan \$600.00)
ON THE FOLLOWING DESCRIBED REAL ESTATE SITUATED IN THE COUNTY OF Sublette STATE OF Wyoming

SW 1/4 Section 12, T33N, R109W.

AND WHEREAS THE BORROWER HAS AGREED TO GIVE COMMODITY CREDIT CORPORATION OR ITS APPROVED LENDING AGENCY A
MORTGAGE LIEN ON SAID STORAGE STRUCTURES;

- NOW, THEREFORE, THE PARTIES HERETO DO COVENANT AND AGREE THAT SUCH STRUCTURES AND EQUIPMENT:
1. SHALL REMAIN SEVERED FROM SAID REAL ESTATE, AND
 2. EVEN IF ATTACHED TO THE REALTY, SHALL RETAIN THEIR PERSONAL CHARACTER, SHALL BE REMOVABLE FROM THE REAL ESTATE, SHALL BE TREATED AS PERSONAL PROPERTY WITH RESPECT TO THE RIGHTS OF THE PARTIES, AND SHALL NOT BECOME FIXTURES OR A PART OF THE REAL ESTATE; AND
 3. SHALL NOT BE SUBJECT TO THE LIEN OF ANY SECURITY TRANSACTION OR INSTRUMENT HERETOFORE OR HEREAFTER ARISING AGAINST THE STRUCTURE OR REALTY ON WHICH IT IS PLACED UNTIL,

- (A) THE EXPIRATION OF COMMODITY CREDIT CORPORATION'S LIEN AND ANY EXTENSION OR RENEWAL THEREOF; AND,
(B) UNTIL REPAYMENT OF SAID LOAN.

4. IF ACQUIRED BY COMMODITY CREDIT CORPORATION OR OTHER PERSON, THROUGH REPOSSESSION, FORECLOSURE OR BY OTHER MEANS, THE STRUCTURE MAY THEN REMAIN ON SAID REAL ESTATE FOR A PERIOD OF SIX MONTHS AT THE OPTION OF, AND WITH NO COST TO THE COMMODITY CREDIT CORPORATION OR OTHER PERSON ACQUIRING THE STRUCTURE; AND DURING SUCH PERIOD THE OWNER OF THE STRUCTURE AND THE AGENTS AND INVITEES OF SUCH OWNER, SHALL HAVE FULL AND FREE ACCESS TO SAID STRUCTURE FOR ALL LAWFUL PURPOSES.

HEREBY RELEASING AND WAIVING ALL RIGHTS UNDER AND BY VIRTUE OF THE HOMESTEAD EXEMPTION LAWS OF THIS STATE.
